Processing of Season Passes—If you need instructor passes for early in the season, you must have your paperwork fully completed (this includes application, and a digital head shot, and a copy of your highest level certification)

Rules and Regulations

- All persons entering Lake Millbrook **Must** complete and sign a waiver.
- All Divers **Must** Present proof of certification from a nationally recognized training agency, the only exception is those participating in diving classes under the direct supervision of a certified instructor.
- No one is permitted to scuba dive alone (NO SOLO DIVING) – This policy will be reexamined in the near future.
- No artifacts, property, or underwater structures may be chipped, damaged, marked, or removed from the site. (touched or moved in any way)
- No shoreline entries are permitted anywhere except the path and entry point at Sunset Beach.
- Use of any underwater propulsion vehicle **must** be prearranged and approved.
- No spear guns or other weapons are allowed. (no exceptions)
- All persons must observe posted speed limits at all times. (5 MPH)
- Parking in designated areas **only**.
- All Freediving Activities **must** be preapproved.
- All CCR activities **must** be preapproved.
- All persons must use approved water entry and exit points only.
- Do not interact with wildlife (in water or out of water) in any way.
- Obey all posted ‘No Go’ zones, and those indicated on map, as these are protected sites.
- No feeding the fish, birds, etc.
- All Divers must be out of the water one (1) hour prior to closing.
- Campfires are only permitted in designated fire pits, and are only for camp nights unless preapproval is obtained.
- No Motorboats or sailboats allowed.
- No Fishing at any time.
- Picnic tables are on a first come, first serve basis.
- No alcohol or illegal drugs permitted on site.
- All children must be accompanied by a parent or guardian.
- No Training activities will be conducted without a current Instructor Pass

WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK, RELEASE OF LIABILITY, AND INDEMNITY AGREEMENT

Please be aware: by signing this document you are waiving certain rights, including the right to sue.

Please read and be certain you understand the implications of signing this document. This form is to be used for all swimming, snorkeling, freediving, and scuba diving activities at Millbrook Quarry, near Thoroughfare, Virginia.

I, _____ Diver's Name _____ do hereby affirm and acknowledge the inherent hazards and risks associated with Scuba diving and/or snorkeling and/or freediving and/or swimming. I fully understand that these risks can lead to severe injury and even death.

In consideration of permitting me, _____ Diver's Name _____ to participate in swimming, snorkeling, freediving, scuba diving activities and/or related operations conducted at the facility known as Millbrook Quarry near Thoroughfare, Virginia and for other good and valuable consideration, receipt of which is hereby acknowledged.

I, for myself, my personal representatives, heirs and next of kin do HEREBY acknowledge that SNORKELING AND/OR SCUBA DIVING AND/OR FREEDIVING AND/OR SWIMMING ARE POTENTIALLY DANGEROUS ACTIVITIES and involve the risk of serious injury and/or death and/or property damage;

HEREBY RELEASE, WAIVE, DISCHARGE AND AGREE NOT TO SUE QUARRY LLC, or CORAL EDGE ADVENTURES LLC, its facility, or any of its officers, instructors, agents, or employees (the Release's) from all liability resulting in any and all loss or damage, and any claim or demand therefore on account of injury to my person or property or resulting in my death, now and forever, arising out of or related to participation in said activities, or other related diving operations or swimming that may occur, whether caused by the negligence of the Release's, or otherwise;

HEREBY EXPRESSLY ASSUME FULL RESPONSIBILITY FOR ANY RISK OR BODILY INJURY, WRONGFUL DEATH OR PROPERTY DAMAGE, now and forever, arising out of, or related to participation in said activities, swimming, or other related operations, whether foreseen or unforeseen and whether caused by the negligence of the Release's or otherwise;

HEREBY acknowledge that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OR THE RELEASES and agree that this Waiver of Claims, Release of Liability, Express Assumption of Risk, and Indemnity Agreement extends to all acts of negligence of Release's, INCLUDES NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as permitted by the law of the Province or State in which the activities are conducted;

I EXPRESSLY agree to INDEMNIFY and SAVE and HOLD HARMLESS the QUARRY LLC, OR CORAL EDGE ADVENTURES LLC, its facility, or any of its officers, instructors, agents, or employees (the Release's) from any loss, liability, damage or cost that they may incur, now and forever, arising out of swimming or arising out of, or related to, participation in said activities, or any other related diving operations, whether caused by the negligence of the Release's or otherwise;

If any provision of the document is found to be unenforceable or invalid, that provision shall if possible be modified to the extent deemed necessary to make the provision enforceable and valid, and if necessary, be served from this contract. The remainder of this contract will then by constructed as though the unenforceable provision had never been contained in this document.

In executing this document, I am not relying on any oral or written representations or statements made by the Release's, other than what is set forth in this agreement.
